




Worldwide Regulated Open-ended Fund Assets and Flows

Trends in the Fourth Quarter of 2021



Brussels, March 22, 2022 – Worldwide regulated open-ended fund assets increased by 6.4 percent in euro terms to EUR 67.3 trillion in Q4 2021.¹ Worldwide net cash flow to all funds amounted to EUR 1,023 billion, compared to EUR 702 billion in Q3 2021.



¹ The information presented in this report was compiled by EFAMA and the Investment Company Institute (ICI) on behalf of the International Investment Funds Association (IIFA), the organization of national investment fund associations. Statistics from 46 countries are included in this report. All data presented in this report include funds of funds, exchange-traded funds and institutional funds.

Worldwide investment fund net assets measured in U.S. dollars increased to USD 76.3 trillion at the end of Q4 2021. This represented an increase of 3.9 percent. The following two graphs compare the net asset growth in the seven largest countries/regions.



On a euro-denominated basis, worldwide equity fund assets increased by 7.9 percent to EUR 30.2 trillion at the end of Q4 2021. Bond fund assets increased by 2.8 percent to EUR 12.5 trillion. Multi-asset funds increased by 5.5 percent to EUR 11.4 trillion. Money market funds increased by 6 percent to EUR 7.8 trillion.




At the end of Q4 2021, 44.9 percent of worldwide regulated open-ended fund net assets were held in equity funds. The share of bond funds amounted to 18.5 percent and the asset share of multi-asset funds was 16.9 percent. Money market fund assets represented 11.6 percent of the worldwide total.

(by Type of Fund, 2021:Q4)**




Looking at the worldwide distribution of investment fund net assets at end Q4 2021, the United States and Europe held the largest shares in the world market, with 49 percent and 31.4 percent, respectively. China (4.6%), Australia (3.4%), Canada (3.3%), Japan (3.2%), Brazil (2.5%), Republic of Korea (0.9%), India (0.7%) and South Africa (0.3%) follow in this ranking.



Overall, five European countries ranked among the top ten largest fund domiciles in the world: Luxembourg (with 8.7 percent of worldwide investment fund assets), Ireland (6%), Germany (4.1%), France (3.3%), and the United Kingdom (3.2%).



Net sales of worldwide regulated open-ended funds increased to EUR 1,023 billion in Q4 2021, from EUR 702 EUR billion in Q3 2021. Long-term funds recorded net inflows of EUR 753 billion, up from EUR 683 billion in Q3 2021. Net sales of money market funds increased to EUR 270 billion, compared to EUR 19 billion in Q3 2021.



Globally, equity funds recorded net inflows of EUR 271 billion, compared to EUR 198 billion in Q3 2021. Bond funds registered net inflows of EUR 206 billion, down from EUR 287 billion in Q3 2021. Multi-asset funds increased from EUR 166 billion in Q3 2021 to EUR 168 billion in Q4 2021.



Net sales of regulated open-ended funds amounted to EUR 261 billion in Europe, mainly driven by net inflows in Ireland (EUR 127 billion), Luxembourg (EUR 93 billion), Germany (EUR 59 billion) and France (EUR 26 billion).

The United States recorded net inflows of EUR 442 billion in Q4 2021, more than the double of the Q3 2021 inflows (EUR 220 billion). Money market funds attracted the strongest net inflows (EUR 187 billion), followed by equity funds (EUR 147 billion) and bond funds (EUR 92 billion).

The Asia-Pacific region² registered net inflows of EUR 180 billion (of which EUR 135 billion in China and EUR 28 billion in Japan). The Americas³ recorded net inflows of EUR 139 billion (of which EUR 78 billion in Canada and EUR 60 billion in Brazil).

All regions registered an increase in net sales compared to Q3 2021.



In Europe, long-term funds recorded net inflows of EUR 169 billion, compared to EUR 206 billion in Q3 2021. Equity funds recorded net sales of EUR 41 billion, down from EUR 57 billion in Q3 2021. Bond funds registered net outflows of EUR 15 billion, compared to net inflows of EUR 67 billion in Q3 2021. Net sales of multi-asset funds amounted to EUR 71 billion, down from EUR 75 billion in Q3 2021.

European money market funds registered net inflows of EUR 92 billion, compared to net outflows of EUR 10 billion in Q3 2021.

In the United States, net inflows of long-term open-ended funds amounted to EUR 256 billion, up from EUR 213 billion in Q3 2021. Equity funds recorded net inflows of EUR 147 billion, compared to EUR 73



billion in Q3 2021. Net sales of bond funds decreased from EUR 130 billion in Q3 2021 to EUR 92 billion in Q4 2021. Multi-asset funds registered net inflows of EUR 18 billion, compared to EUR 13 billion in Q3 2021.

Money market funds in the United States recorded net inflows of EUR 187 billion, up from EUR 8 billion in Q3 2021.
