





Highlights of Developments in 2024

(EUR trillions, percent)






Highlights of Developments in Q4 2024

Worldwide regulated open-end fund assets increased by 6% in euro terms to EUR 76.29 trillion in Q4 2024.¹ Worldwide investment funds registered net inflows of EUR 1,247 billion, compared to EUR 824 billion in Q3 2024.



¹ The information presented in this report was compiled by EFAMA and the Investment Company Institute (ICI) on behalf of the International Investment Funds Association (IIFA), the organization of national investment fund associations. Statistics from 46 countries are included in this report. All data presented in this report include funds of funds, exchange-traded funds and institutional funds.

Worldwide investment fund net assets measured in U.S. dollars decreased by 1.7% to USD 79.3 trillion at the end of Q4 2024. This net asset decrease measured against the euro reflects the strong appreciation of the dollar vis-à-vis the euro during Q4 2024. The following two graphs compare the net asset growth in the seven largest countries/regions.




On a euro-denominated basis, worldwide equity fund assets increased by 6.6%, reaching EUR 35 trillion at the end of Q4 2024. Bond fund assets rose by 4.6%, totalling EUR 13.8 trillion. Multi-asset funds recorded growth of 2.2%, reaching EUR 10.9 trillion. Money market funds (MMFs) grew sharply by 11.4% to reach EUR 11.2 trillion. Other funds also registered increases in net assets of 3.1%. Real estate funds were the only category to decline, noting a slight decrease of 0.4% in net assets during the quarter.



At the end of Q4 2024, equity funds accounted for 45.9% of worldwide regulated open-end fund net assets. The share of bond funds amounted to 18%, and the asset share of multi-asset funds was 14.3%. MMF assets represented 14.6% of the worldwide total.





Looking at the breakdown of worldwide investment fund net assets per domicile at the end of Q4 2024, the United States held the largest global market share, with 53.3%. Europe ranked second, with a market share of 29.8%. China (5%), Canada (3.1%), Japan (3%), Brazil (2.7%), India (1%), Republic of Korea (0.9%), Chinese Taipei (0.4%) and South Africa (0.3%) follow in this ranking.





Overall, five European countries ranked among the top ten largest fund domiciles in the world: Luxembourg (with 7.6% of worldwide investment fund assets), Ireland (6.5%), Germany (3.7%), France (3.3%), and the United Kingdom (2.8%).

Net sales of worldwide regulated open-end funds reached EUR 1,247 billion in Q4 2024, compared to EUR 824 billion in the previous quarter. Long-term funds saw net inflows of EUR 702 billion, a significant increase from EUR 457 billion in Q3 2024. Net sales of MMFs amounted to EUR 545 billion, up from EUR 367 billion in Q3 2024.



Globally, equity funds saw net inflows of EUR 354 billion, up from EUR 230 billion in Q3 2024 and a new record. Bond funds recorded net inflows of EUR 297 billion, up from EUR 224 billion in the previous quarter. In contrast, multi-asset funds continued to experience net outflows (EUR 5 billion), marking the eleventh consecutive quarter of negative net sales.

ETFs registered net inflows of EUR 551 billion in Q4 2024, an increase from EUR 461 billion in Q3 2024. The strong inflows in Q4 2024 were primarily driven by the United States (EUR 395 billion), followed by Ireland (EUR 78 billion). For the entire year 2024, worldwide net sales of ETFs totalled EUR 1,665 billion, nearly doubling from EUR 896 billion in 2023.



During Q4 2024, Europe recorded net inflows of EUR 241 billion, up from EUR 182 billion in Q3 2024. Net inflows were primarily driven by Ireland (EUR 131 billion), Luxembourg (EUR 32 billion), Germany (EUR 18 billion) and France (EUR 13 billion). Most European countries saw positive inflows over the quarter, except for the Netherlands, which experienced net outflows of EUR 5 billion.

The United States recorded net inflows of EUR 795 billion in Q4 2024, a significant increase from EUR 485 billion in Q3 2024. This growth was mainly fuelled by robust net inflows into money market funds and equity funds.

In the rest of the Americas, Canada saw strong net inflows of EUR 78 billion, up from EUR 23 billion in Q3 2024. In contrast, Brazil experienced large net outflows of EUR 38 billion.

In Asia, net inflows were primarily driven by China (EUR 100 billion), followed by India (EUR 24 billion) and Japan (EUR 15 billion).



European long-term funds recorded net inflows of EUR 170 billion in Q4 2024, compared to EUR 85 billion in Q3 2024. All fund categories registered positive inflows during the quarter. Bond funds remained the top-selling category, attracting net sales of EUR 91 billion. Equity funds saw strong net inflows of EUR 63 billion in Q4 2024, up from EUR 22 billion in Q3 2024. Multi-asset funds experienced modest net inflows of EUR 8 billion, slightly higher than the EUR 6 billion recorded in Q3 2024.


European MMFs saw net inflows of EUR 70 billion in Q4 2024, down from EUR 96 billion in Q3 2024.

In the United States, long-term open-end funds reported net inflows of EUR 391 billion in Q4 2024, up from EUR 188 billion in Q3 2024. Equity funds saw net inflows of EUR 203 billion in Q4, up from EUR 62 billion the quarter before. Bond funds recorded net inflows of EUR 175 billion, compared to EUR 162

billion in Q3 2024. Net sales of multi-asset funds turned positive again, experiencing modest net inflows of EUR 10 billion, compared to net outflows of EUR 41 billion in Q3 2024.

US MMFs recorded net inflows of EUR 404 billion, a notable increase from EUR 297 billion in Q3 2024.

Net sales of long-term open-end funds in China amounted to EUR 26 billion, compared to EUR 34 billion in Q3 2024. This was mainly a consequence of a drop in the net sales of equity funds, from EUR 84 billion in Q3 2024 to EUR 21 billion in Q4 2024.

The Chinese MMF market, which is notably well-developed, saw a strong upswing in net sales from net outflows of EUR 20 billion in Q3 2024 to net inflows of EUR 74 billion in Q4 2024.

In Canada, the recovery of net sales during Q4 2024 was chiefly driven by net inflows into equity funds (EUR 39 billion), multi-asset funds (EUR 23 billion) and bond funds (EUR 13 billion).

Net sales in Japan dropped to EUR 15 billion in Q4 2024, compared to EUR 31 billion in Q3 2024, as the net inflows of equity funds declined from EUR 34 billion to EUR 11 billion.

In Brazil, net sales turned negative in Q4 2024, mainly due to net outflows from multi-asset funds (EUR 25 billion) and, to a lesser extent, bond and money market funds (EUR 8 billion).

Indian investment funds saw net inflows of EUR 24 billion in Q4 2024, similar to EUR 24 billion in Q3 2024.

Among the other countries (Rest of World), it was mainly other Asian countries that accounted for the rest of the net inflows, with Chinese Taipei (Taiwan) attracting EUR 15 billion in net sales in Q4 2024.
